# **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction target:

We project that carbon emissions will decrease over the next five years to 837 tCO2e by 2029. This is a reduction of 26%, and aligns with Pennine Healthcare's plan to reduce scope 1 and 2 emissions to zero by 2040, and all emissions to zero by 2045.

# **Carbon Reduction Projects**

#### **Completed Carbon Reduction Initiatives**

During this reporting period, the following activities have been implemented by Pennine Healthcare to directly reduce emissions as part of their net zero programme:

- 1. Piloted solution to turn off Air Handling Units when cleanroom not in operation
- 2. Replaced final 5% of lighting with LED-based technology
- 3. Installed energy monitors in a number of locations across the premises
- 4. Launched Black Belt project to assess opportunities for reducing energy usage
